



# RABUN RAMBLE SPONSORSHIP

For 17 years, Lake Rabun families and friends have kicked off the 4th of July holiday weekend with the running of the Rabun Ramble. While this is a fun, healthy community event, it also serves as an annual fundraiser for the Lake Rabun Foundation. Net proceeds from the race go to support the work of the Lake Rabun Foundation as well as donations made to Rabun County Search and Rescue and the Lakemont Wiley Volunteer Fire Department Association.

Since its inception in 1987, the Lake Rabun Foundation has provided almost \$1.5 million in scholarship assistance to more than 220 Rabun County students. This year, 50+ Rabun students are attending colleges, technical schools and graduate programs with financial aid from the Foundation. In addition, the Foundation seeks to improve lives in Rabun County with grants to organizations involved with education, child and family welfare, food ministries, environmental programs, and community development.
